All components of the equipment supplied by the bidder shall be covered under warranty, including batteries, antennae etc.	The clause is amended as follows :- "All components of the equipment supplied by the bidder, except batteries, shall be covered under warranty for minimum two years. Batteries shali be covered under warranty for a period of six months. The batteries shall be repaired or replaced if they are not able to hold charge for more than 4 hours after full recharging. Onsite services shall be provided for any repair or replacement during the warranty period.

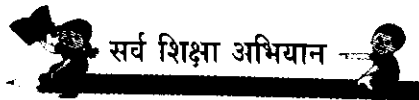




