**4. Mode of Selection:**

The selection shall be carried out through Personal Interview only. The candidates will have to pass through each stage including Medical fitness successfully for being adjudged suitable for selection.

**5. General Conditions:**

- a. - b. A candidate can apply for one post only. Candidates applying for more than one post will not be considered.
- c. All the qualifications should be full time regular courses from a Government recognized University / Institute.
- d. The candidates should attach photocopies of original certificates, attested by a Gazetted Officer, in support of age, educational qualification, experience, caste (for SC / ST / OBC candidates) and physical disability certificate along with their applications, failing which their application will be rejected.
- e. The period of experience will be determined upto 28/02/2010.
- f. Candidates applying against Physically Challenged category shall have not less than 40% of relative disability. An attested copy of the Disability Certificate issued by the competent authority, viz. a Medical Board duly constituted by the Central or State Government shall be furnished, while applying, failing which their application will be rejected.
- g. For claiming the benefit of OBC category, the candidate should submit a proper Caste Certificate as per the proforma prescribed by the Government of India, which would, among others, specifically mention that the candidate does not belong to the persons/sections (Creamy Layer) as mentioned in column 3 of the Schedule to the Department of Personnel and Training in the Govt. of India OM No.36012/22/93-Estt.(SCT) dated 08-09-1993.
