**1. Correction in the Item description of SOR for TATA Sierra Vehicle**

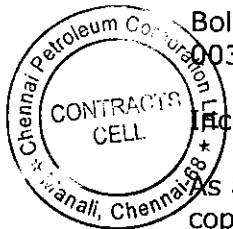
Tender document comprising Techno commercial and Price parts for the subject tender was published in our website vide NIT dated 10.8.2011. Subsequently, considering the request of the bidders who had participated in the pre bid meeting to rearrange the grouping of vehicles, revised price bid was published vide Corrigendum No. 3 dated 26.9.2011. Bidders were requested to discard the Price bid document originally published with the tender document and offer their price in the revised price bid document only.

On review of the revised price bid document, one of the bidders had informed that the "Tata Sierra Half body Vehicle" mentioned in Item No. 00190, 00200, 00210, 00310, 00320 and 00330 is not available in the market. On our enquiry in the market it was confirmed that "Tata Sierra" is not available in the market. Alternately, vehicle by name "Mahindra Bolero Camper Half body vehicle" can be a suitable replacement for "Tata Sierra" vehicles which are mentioned in the tender document as stated above.

In view of the above, it is necessary to revise the Item description as detailed above. Bidders are requested to note the above change and read the vehicle name as "Mahindra Bolero Camper Half body vehicle" for Item no. 00190, 00200, 00210, 00310, 00320 and 00330. Bidders shall offer their price for "Mahindra Bolero Camper Half body vehicle" only for Item no. 00190, 00200, 00210, 00310, 00320 and 00330.

Inconvenience caused to the bidders in this regard is regretted.

**2. Due date of Submission:**


